### Terms and conditions of the 5 years extended guarantee:

The extended guarantee of EP S.p.A. has no influence on the rights of the user indicated in the National Program of Guarantee.

The duration of the extended guarantee is 5 years and it includes the validity period of the standard guarantee that begins from the date of the purchase or the date of supply.

The registration and the activation of the extended guarantee should be made within 30 days from sale of the products by filling the "Five- year extended guarantee registration form" available at Lanzini sales department or on the web site <http://www.lanzini.it>.

The request has to be sent by fax, e -mail or registered letter directly to EP S.p.A.

The activation of the extended guarantee is subject to the approval of EP S.p.A. that reserves the right to decide to apply it on each individual system.

The value of the guarantee cannot be higher than the value of the supplied goods.

In the event that the defect is recognized by EP S.p.A., it will choose at its discretion whether to repair or replace the defective product with the same product or equivalent, taking into consideration the technical evolution of the

products and that of their components.

In the case of successive supplies of LED light sources, there may be deviations from the primitive products, for regarding the characteristics of light.

The extended guarantee is only liable for defects found in electronic components, LEDs, and for breaks or defects of the mechanical parts with the exception of the normal wear and the aesthetic deterioration, as long as the products of the extended guarantee were installed and used in accordance with what indicated in the installation and use manual and what indicated from the customer in the "5 years extended guarantee form" sent to Lanzini that accepted it.

The performances and the duration of the LEDs are not guaranteed if the appliances are installed in environments with presence of chemicals not compatible with the LEDs themselves. Our technical office is available to check the compatibility of the LEDs that we use in relation to the substances present in the environment where they are installed

This warranty does not guarantee the integrity of the paint when the product is used in an environment saline or in the presence of corrosive agents.

EP S.p.A. reserves the possibility of asking for more detailed information on the installation and / or on the complete light fittings to better check the defect.

Operations made on the products having extended guarantee do not extend its duration in comparison with the legal guarantee.

The guarantee is not applicable if the conditions of installation do not respect what indicated in the installation manual and if the use of the product is incorrect.

The guarantee loses its right in case of non-conform installation, use and exercise, and intervention of non-authorized personnel by EP S.p.A.

The extended guarantee is not applicable to reported defects after the expiry of the period of validity of the guarantee.

For the services made to correct the defects resulting from conditions that are excluded from the guarantee, the customer is required to pay additional costs for labor, transportation and spare parts.

The depreciation of the luminous flux is an expected phenomenon during the life of the LED and is therefore not covered by warranty.

Any costs of storing the defective / flawed product, or any other charge and / or compensation for damages can not be charged to EP S.p.A, as well as the Customer will not have the right to request delays in payments, price reduction or termination of the supply contract.

## Privacy policy Ep S.p.A.

This document describes the conditions of management and personal data processing observed by EP S.p.A. It is a notice pursuant to the art. 13 of the Legislative Decree no. N. 196/2003 - Code regarding personal data protection from those who interact with the services of the Owner, in particular the web services accessible via internet from the following web address: <http://www.lanzini.it>

This notice applies only to the above web site and not to other web sites accessed via links. This statement is inspired also to the Recommendation no. 2/2001 that the European authorities for the protection of personal data, gathered in the Group established by the art. 29 of Directive no. 95/46/EC, adopted on the 17th of May 2001 to establish the minimum requirements for the collection of personal data online, and, in particular, the conditions, the times and the nature of the information to give to the users when connecting to web pages, apart from the purpose of the link.

### The "Owner" of the treatment

### Types of processed data

#### Web Navigation data:
